

ELECTION NOTICE

A Presidential Preference Primary (Republican and Democratic) and a County Primary (Republican only) is hereby called for Montgomery County, Tennessee for Tuesday, March 1, 2016 between the hours of 7:00 am and 7:00 pm at the various precincts for the purpose of voting a preference for a Presidential candidate of each political party and delegate candidates for the National Convention.

QUALIFYING DEADLINES: President: Noon - Dec 1, 2015
Delegate: Noon - Dec 10, 2015

The County Republican Primary will select Republican nominees for Circuit Court Judge, Part III (unexpired term), Circuit Court Judge, Part IV (unexpired term), Assessor of Property and Highway Supervisor. The County Democratic Party did not call for a county primary.

QUALIFYING DEADLINE:

Circuit Court Judge, Part III: Noon - Dec 10, 2015
Circuit Court Judge, Part IV: Noon - Dec 10, 2015
Assessor of Property: Noon - Dec 10, 2015
Highway Supervisor: Noon - Dec 10, 2015

Any person interested in running for office should contact the Montgomery County Election Commission Office for further information. The office is located in the Montgomery Veterans Plaza, 350 Pageant Lane, Suite 404, Clarksville, Tennessee or call 931-648-5707. Office hours are Monday thru Friday 8:00 a.m. to 4:30 p.m.

The last day to register to vote before the March 1, 2016 election is February 1, 2016.

Pursuant to TCA 2-7-133(i) and TCA 2-8-113(c) notice is hereby given that any person attempting to be elected by write-in ballots or receive a party's nomination by write-in ballots shall complete a notice requesting such person's ballots be counted in each county of the district no later than noon, fifty (50) days before the election or primary election. Such person shall only have votes counted in counties where such notice was completed and timely filed. Write-in candidates in elections for the offices of Governor, United States Senate and United States House of Representatives shall file their notice with the state coordinator of elections. The notice shall be on a form prescribed by the coordinator of elections and shall not require signatures of any person other than the write-in candidate requesting ballots be counted. The coordinator of elections shall distribute such form to the county election commissions.

Last Day for Write-in candidate to file notice: Noon on January 11, 2016. Forms are available in the Montgomery County Election Commission Office.

NEW STATE LAW: Federal or Tennessee State government issued photo ID is now required to vote, unless an exception applies. College student IDs will not be accepted. To learn more about the new law and its exceptions, go to www.mcgtm.org/election.
